A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FORNEY, TEXAS AWARDING THE CONTRACT FOR HEALTH INSURANCE BENEFITS TO BLUE CROSS/BLUE SHIELD OF TEXAS; AWARDING THE EMPLOYEE DENTAL INSURANCE BENEFITS TO PRINCIPAL; AWARDING THE EMPLOYEE VISION INSURANCE BENEFITS TO GUARDIAN; AWARDING THE EMPLOYEE BENEFITS FOR LIFE/DIABILITY INSURANCE TO MUTUAL OF OMAHA; AWARDING A CONTRACT FOR SERVICES TO ALIGHT SOLUTIONS FOR EMPLOYEE COORDINATION OF COMPLEX CARE AND ASSISTANCE; AWARDING A CONTRACT TO TELEDOC HEALTH FOR MEDICAL CONSULTATION SERVICES; AWARDING A CONTRACT FOR COBRA, HRA AND FSA SERVICES TO FLORES & ASSOCIATES; AUTHORIZING THE CITY MANAGER TO TAKE ALL ACTION NECESSARY ON BEHALF OF THE EMPLOYEE BENEFITS TRUST TO COMPLY WITH THIS RESOLUTION FOR CALENDAR YEAR 2020; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Forney, Texas (the "City") has received proposals for employee benefit rates including health insurance, dental and vision insurance, life/disability insurance, and other employee benefits and assistance services; and

WHEREAS, the City desires to award contracts through the Employee Benefits Trust for the provision of insurance benefits and other services for the use and benefit of the employees of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORNEY, TEXAS:

SECTION 1. The above and foregoing premises are true and correct and are incorporated herein and made part hereof for all purposes.

SECTION 2. That the City awards the contract for the provision of health insurance benefits to Blue Cross/Blue Shield of Texas and awards the contract for dental insurance to Principal, the contract for vision insurance to Guardian, and life/disability insurance to Mutual of Omaha.

SECTION 3. That the City award the contract for services to Alight Solutions for employee coordination of complex care and assistance with the health care system, award a contract for services to Teledoc Health for medical consultation services, and award a contract to Flores & Associates for Cobra, HRA and FSA services.

SECTION 4. The City Manager is hereby authorized on behalf of the Employee Benefits Trust to enter into Agreement with the various providers for employee benefits and assistance services.

SECTION 5. This Resolution shall take effect immediately from and after its passage.
